The first article of the current issue entitled "*Local crime prevention policies: A critical approach to methodological and evaluation issues*" by Christina Zarafonitou (Panteion University), Charalampos Karagiannidis (Aristotle University of Thessaloniki) and Eleni Kontopoulou (Panteion University), focuses on *local crime prevention policies* and their methodological context. More specifically, common elements in methodology are highlighted as prerequisites for the success of local crime prevention policies, while special focus is placed on evaluation as the cornerstone for advancing scientific knowledge and promoting the development of effective, sustainable and replicable local crime prevention policies.

The second article titled "Assessing perception of spatial dimensions of Farmer-Herder Land Conflicts (FHLCs) in sub-Saharan Africa: a study case in Oke-Ogun, Nigeria" is a contribution by Albert Abegunde (Obafemi Awolowo University), Anthony Owolabi (Obafemi Awolowo University), Henry Afolabi (Obafemi Awolowo University) and Adewumi Badiora (Olabisi Onabanjo University). The article provides a thorough analysis on farmer-herder land conflicts in Oke-Ogun, Nigeria, examining the perception of spatial dimension including causes and effects on the physical and socioeconomic environment.
